Dear Sigma Nu,

Based on the information presented and discussed, your organization, Sigma Nu Fraternity, accepts Responsibility for their actions, which constituted a violation of LSU's Code of Student Conduct, specifically:

10.2 Failure to Comply -- Responsible

As a result of the incident that occurred on November 20, 2020, where Sigma Nu Fraternity hosted a semiformal event at an off campus residence, your organization has submitted an Enhancement Plan. This will meet the requirements of the partnership process with Greek Life/Campus Life and Student Advocacy & Accountability:

Organization Disciplinary Probation

This accountability status will be effective April 15, 2021 through December 31, 2021. During this time, the organization will be required to complete outcomes and may forfeit certain privileges which may include, but is not limited to, loss or limitation of social events or inability to participate in University events or activities. Disciplinary probation will be reflected on the Student Organization Scorecard.

With respect to the information listed above, the following additional sanctions/stipulations apply:

1. The Chapter will not host any social events with alcohol prior to September 19, 2021 and after additional training has been completed as outlined in this enhancement plan.

2. The Chapter leadership (executive board and committee chairs/members) will participate in a social event planning workshop by August 1, 2021. The workshop will create a risk management and prevention plan for the Chapter and will be conducted by a member of Headquarters. The Chapter will submit verification that the workshop occurred as well as the plan to Greek Life and SAA by August 15, 2021. 3. The Chapter president and advisors will meet with the Chapter to share an overview of the Chapter's disciplinary status, the incident that led to the status, and expectations moving forward by May 7, 2021. The Chapter will have 90% membership in attendance. The Chapter will submit verification that the presentation occurred to SAA by May 14, 2021.

4. The Chapter executive board will not meet unless an advisor and social chair, and risk manager are present. All social events will be proposed and discussed during executive board meetings in perpetuity.5. The chapter will facilitate the judicial board process to hold all members present at unauthorized social event as well as the members who authorized the event.

The following items will be completed by the deadline indicated and with verification of each item's completion submitted to Student Advocacy & Accountability using the <u>online reporting form</u> or via email to the student and the student a

The Enhancement Plan and Accountability Outcome will be kept on file in Student Advocacy & Accountability within the Office of the Dean of Students. The Enhancement Plan will also be shared with all relevant LSU and headquarters staff.
